2021-2022 SCHOOL BUS REGISTRATION FORM**

Parent/Guardian: Please complete this form and return to your child's school or the district office, or mail to Benjamin Bus at the address below.

- **IMPORTANT:** Updated forms are sent home each May. Forms **MUST** be updated/filled out each year, if a form is not received your student will **NOT** be registered for bus service.
- Please allow up to 5 business days for changes to transportation arrangements. *Changes that result in significant adjustments to a route may take longer.*

WHO IS ELIGIBLE FOR TRANSPORTATION?

- + **MIDDLE and HIGH SCHOOL** students (6-12) living approximately One (1) or more miles from school **ARE** eligible for bus service.
- + **ELEMENTARY** students living approximately 3/4 mile or more from school **ARE** eligible for bus service.
- + **OPEN ENROLLED STUDENTS** are transported **ONLY** on routes *inside* that district that have been established to serve district residents. Most stops will be group stops.

X **NO** new stops will be added for open enrolled students.

X **NON-RESIDENT** students who attend charter, private or parochial schools in the Northfield School District are **NOT ELIGIBLE** for school bus service.

X **TRANSPORTATION IS NOT PROVIDED ON REGULAR ROUTE BUSES** for after school, work or extra-curricular activities. The district provides transportation from only one pick up and one drop off location. There **may** be sports/activity shuttles that run from the Middle School /High School. Contact your activities coordinator for more details.
